Chapters cover topics including the definition of terms, the system of courts and tribunals with jurisdiction for Community Design disputes, overlap with other intellectual property rights, exclusions from protection, the unification of design rights across the EU, the right to the Community Design, assessment and invalidity of prior design and novelty arguments, the procedure of the OHIM, infringement and applicable defenses, jurisdictional issues, and the Design Directive.
